Information about processing your data, according to article 13 General Data Protection Regulation (GDPR)

1. **Responsible authority for processing your personal data**

2. **Data security engineer**

3. **Purpose for processing data and legal basis**
Purpose: protection of visitors and employees from COVID-19-infections and the possibility of back tracing of infections with COVID-19; legal basis for data processing is article 6 paragraph 1 letter of the GDPR (processing personal data for the protection of vitally important interests of the data subject or any other natural person). This includes the processing of personal data for the monitoring of epidemics and their proliferation.

4. **Recipient of the processed personal data**
The processed data is solely allowed to be handed out after the request of the appropriate health authority for (back) tracing of possible paths of infection.

5. **Length of processing**
The personal data will be stored up until one month after the course took place and will then be destroyed, compliant with the data protection act.

6. **Legal rights in relation to the data processing act**
You have the right ...
 - a. to obtain information about the personal data saved about you personally,
 - b. to demand the deletion or limit the processing as well as to lodge an objection against the processing and
 - c. to file a complaint at our Data Protection Supervisory Authority, the Baden-Württembergischen Representative for Data Security (Königsstraße 10a, 70173 Stuttgart; Telefon 0711 6155410).
